Impeaching Donald John Trump, President of the United States, for high crimes and misdemeanors.

- 1 Resolved, That Donald John Trump, President of the
- 2 United States, is impeached for high crimes and mis-
- 3 demeanors and that the following article of impeachment
- 4 be exhibited to the United States Senate:
- 5 Article of impeachment exhibited by the House of
- 6 Representatives of the United States of America in the
- 7 name of itself and of the people of the United States of

- The Constitution provides that the House of Rep-

- 1 officials. Shortly before the Joint Session commenced,
- 2 President Trump, addressed a crowd at the Ellipse in
- 3 Washington, DC. There, he reiterated false claims that
- 4 "we won this election, and we won it by a landslide". He
- 5 also willfully made statements that, in context, encour-
- 6 aged—and foreseeably resulted in—lawless action at the
- 7 Capitol, such as: "if you don't fight like hell you're not
- 8 going to have a country anymore". Thus incited by Presi-
- 9 dent Trump, members of the crowd he had addressed, in
- 10 an attempt to, among other objectives, interfere with the

- 3 In all this, President Trump gravely endangered the
- 4 security of the United States and its institutions of Gov-
- 5 ernment. He threatened the integrity of the democratic
- 6 system, interfered with the peaceful transition of power,
- 7 and imperiled a coequal branch of Government. He there-
- 8 by betrayed his trust as President, to the manifest injury
- 9 of the people of the United States.
- Wherefore, Donald John Trump, by such conduct,
- 11 has demonstrated that he will remain a threat to national
- 12 security, democracy, and the Constitution if allowed to re-
- 13 main in office, and has acted in a manner grossly incom-
- 14 patible with self-governance and the rule of law. Donald
- 15 John Trump thus warrants impeachment and trial, re-
